**MINUTES OF THE INAUGURAL SESSION OF THE SANGGUNIANG PANLUNGSOD
(15th CITY COUNCIL) OF PAGADIAN CITY HELD ON 02 JULY 2025 AT THE SP
SESSION HALL, 4th FLOOR CITY COMMERCIAL CENTER (C3) BUILDING, PAGADIAN
CITY**

CALL TO ORDER:

Honorable Vice Mayor Monique Shaira Y. To, Presiding Officer, convened and officially called to order the Inaugural Session of the 15th City Council at 9:55 in the morning.

**INVOCATION, SINGING OF THE PHILIPPINE NATIONAL ANTHEM AND
RECITATION OF THE “PANUNUMPA SA WATAWAT NG PILIPINAS”:**

At the instance of the Honorable Presiding Officer, Honorable Jackielyn Krystyl C. Bana was temporarily designated Temporary Floor Leader while the Sangguniang Panlungsod (15th City Council) has not yet elected the Floor Leader. Immediately thereafter, the session, accompanied by a prepared audio recording, commenced with the invocation, which was then followed by the mass singing of the Philippine National Anthem, the recitation of the “Panunumpa sa Watawat ng Pilipinas,” the singing of the “Zamboanga del Sur March” and the “Pagadian City Hymn.”

ROLL CALL AND DETERMINATION OF QUORUM:

Quorum was thereafter declared when all of the thirteen (13) Council Members responded to the roll call conducted by the Secretary to the Sanggunian, namely: Honorable Vice Mayor Monique Shaira Y. Pulmones, and Honorable Marylynn U. Tan.

ADOPTION OF THE INTERNAL RULES OF PROCEDURE OF THE 15TH CITY COUNCIL:

At this juncture and, consistent with the provisions of the Local Government Code of 1991 in relation to Article 103 of the Rules and Regulations Implementing the Local Government Code, Honorable Jackielyn Krystyl C. Bana presented a motion to adopt temporarily the Internal Rules of Procedure of the 14th City Council as the Internal Rules of Procedure for the 15th City Council subject, however, later on for the introduction of amendments/revisions as the body may deemed necessary, which motion was severally seconded.

Following a brief deliberation, the body, with no further amendments and/or objections, resolved to approve the motion through the passage of **Resolution No. 2025-0001**, adopting temporarily the Internal Rules of Procedure of the 14th City Council of Pagadian City as the Internal Rules of Procedure of the 15th City Council of Pagadian City.

NOMINATION AND ELECTION OF THE SANGGUNIANG PANLUNGSOD OFFICERS AND THE CHAIRMANSHIP/MEMBERSHIP OF THE DIFFERENT STANDING COMMITTEES:

With reference to the provisions of the recently adopted Internal Rules of Procedure (IRP), the body, at the instance of Honorable Jackielyn Krystyl C. Bana, proceeded to the nomination and election of the Council Officers and Committee Chairmanship, Vice Chairmanship, and Membership of the twenty-three (23) Standing Committees of the 15th City Council. The results of the uncontested nominations and subsequent elections of the officers of the 15th City Council are as follows:

To reminded the Council Members, based on the provisions of the newly adopted Internal Rules of Procedure, that the elected chairperson of the different standing committees was given the prerogative and privilege to choose his/her Vice-Chairperson and members of their respective committees, and that the position of Chairmanship is limited to three (3) Committees only while that of Vice-Chairmanship is limited to five (5) Committees.
