MINUTES OF THE 2nd SPECIAL SESSION OF THE SANGGUNIANG PANLUNGSOD (15th CITY COUNCIL) OF PAGADIAN CITY HELD ON 22 DECEMBER 2025 AT THE SP SESSION HALL, 4th FLOOR CITY COMMERCIAL CENTER (C3) BUILDING, PAGADIAN CITY

CALL TO ORDER:

Honorable Vice Mayor Monique Shaira Y. To, Presiding Officer, convened and officially called to order the 2nd Special Session of the 15th City Council at 1:32 in the afternoon.

INVOCATION, SINGING OF THE PHILIPPINE NATIONAL ANTHEM AND RECITATION OF THE “PANUNUMPA SA WATAWAT NG PILIPINAS:

Upon motion of the Honorable Samuel Lance F. Co who was temporarily designated as Floor Leader, the session, accompanied by a prepared audio recording, commenced with the invocation, which was then followed by the mass singing of the Philippine National Anthem, the recitation of the “Panunumpa sa Watawat ng Pilipinas,” the singing of the “Zamboanga del Sur March,” and the “Pagadian City Hymn.”

ROLL CALL AND DETERMINATION OF QUORUM:

After Honorable Co relinquished the floor to Honorable Jackielyn Krystyl C. Bana, a roll call was made at the direction of the Chair and quorum was declared with the attendance of eight (8) Council Members namely: Honorable Vice Mayor Monique Shaira Y. To, Honorable Roger L. Acedillo, Honorable Jackielyn Krystyl C. Bana, Honorable Ann Marjorie N. Revelo, Honorable Lance Samuel F. Co, Honorable Bienvenido C. Culve, Honorable Ronald Christopher Glenn L. Ariosa, and Honorable Joan Szanne S. Pulmones.

Sometime later on during the course of the proceeding, the presence of Honorable Ariel J. Lim, Jr., Honorable Marylynn U. Tan, and Honorable Maphilindo Q. Obaob were recorded as acknowledged by the Chair. The body also noted that Honorable Patrisha Kaye N. Asugas was on leave while Honorable Ma. Alicia Elena V. Ariosa was out on Official Business.

CURRENT MATTERS:

At this point, the body then proceeded to treat the lone item under Current Matters, the Supplemental Annual Investment (SAIP) No. 2 for CY 2025 with CDC Resolution No. series of 2025 involving the total amount of P42,888,309.10; and Supplemental Budget No. 2 in the amount of P42,888,309.10 of the City Government of Pagadian, for Calendar Year 2025.

Following a recess and, upon resumption, the rules were then suspended to allow the invited personalities to ventilate with the body. Upon recognition, the City Budget Officer, Ms. Rosa Leah S. Arao-arao, presented the certification on the availability of funds as certified by the Local Finance Committee including the certification of the different department heads on the number and position of their respective employees as requested by the Council Members during the previous session. As regards the employees through job order, she explained that although the Memorandum of Employment it was specified as job order however it was verified that their employment status are actually casual employees of the LGU who are also entitled for the Service Recognition Incentives (SRI).

In response to the queries of Honorable Lim, Jr., Ms. Arao-Arao stipulated the list of sources of savings from the different departments of the city out of the personal services as certified available by the Local Finance Committee, and that the estimated total amount for the grant of SRI is at P15,000.00 for each employee is considered a safe amount since there is yet no closing of books for Calendar Year 2025. Furthermore, Atty. Georgina Ariosa-Lopez, City Legal Officer, clarified that giving a uniform amount of P15,000.00 was based on what is available as savings, and that the Productivity Enhancement Incentive (PEI) is already being processed as it is from a different source which is the Annual Budget, which explanation was concurred by Honorable Lim, Jr.

Thereafter, the suspension of the rules was lifted. With no further discussion from the Council Members, the formal motion presented by Honorable Bana and duly seconded, facilitated the adoption of **Resolution No. 2025-0214**, approving and adopting Supplemental Annual Investment Program (SAIP) No. 2, Calendar Year 2025, of the City Government of Pagadian involving the total amount of Forty-Two Million Eight Hundred Eighty-Eight Thousand Three Hundred Nine Pesos and Ten Centavos (P48,888,309.10), as adopted by the City Development Council Executive Committee through its CDC Resolution No. 7, s. 2025

Furthermore, the body, following a brief recess and, on motion of the Honorable Floor Leader and duly seconded, resolved to adopt **Resolution No. 2025-0215**, approving on First Reading Draft Appropriation Ordinance No. 03, entitled: “An Ordinance Declaring The Sum Of Forty-Two Million Eight Hundred Eighty-Eight Thousand Three Hundred Nine Pesos And Ten Centavos (P42,888,309.10) As Available For Appropriation Pursuant To The Certification Issued By The Local Finance Committee And Appropriating The Same Amount For Specified Priority Programs, Projects And Expenditures Of The City Government Of Pagadian”, and for its consideration on Second Reading.

After a recess was declared, the seconded motion of Honorable Bana was supported through the approval of **Resolution No. 2025-0216**, approving on Second Draft Appropriation Ordinance No. 03, entitled: “An Ordinance Declaring The Sum Of Forty-Two Million Eight Hundred Eighty-Eight Thousand Three Hundred Nine Pesos And Ten Centavos (P42,888,309.10) As Available For Appropriation Pursuant To The Certification Issued By The Local Finance Committee And Appropriating The Same Amount For Specified Priority Programs, Projects And Expenditures Of The City Government Of Pagadian”, And For Its Consideration on Third and Final Reading.

Upon resumption after another recess, on formal motion of Honorable Bana and duly seconded, the body adopted **Resolution No. 2025-0217**, approving Draft Appropriation Ordinance No. 03 on Third and Final Reading and ordaining the same as **Appropriation Ordinance No. 03-12-2025**, entitled: “An Ordinance Declaring The Sum Of Forty-Two Million Eight Hundred Eighty-Eight Thousand Three Hundred Nine Pesos And Ten Centavos (P42,888,309.10) As Available For Appropriation Pursuant To The Certification Issued By The Local Finance Committee And Appropriating The Same Amount For Specified Priority Programs, Projects And Expenditures Of The City Government Of Pagadian.

Finally, the body, on separate motions presented by Honorable Bana, adopted the following resolutions, to wit:

- **Resolution No. 2025-0218**, approving the grant and release of Service Recognition Incentive (SRI) to all City Government Officials, Regular Plantilla Personnel and Casual Employees, charged to Lump Sum and Salary Savings at the rate of Fifteen Thousand (P15,000.00) Pesos.

- **Resolution No. 2025-0219**, approving the grant and release of gratuity pay to all employees of the City Government for Fiscal Year 2025 whose services are engaged through Contract of Service at the rate of Seven Thousand Pesos (P7,000.00) each.

ADJOURNMENT:

With no more matters to discuss, the session was declared adjourned on motion of Honorable Bana, following the closing prayer led by Honorable Ronald Christopher Glenn L. Ariosa.
